

LANDSHYPOTEK BANK AB (publ) €10,000,0000 Nordic Medium Term Note and Covered Bond Programme

This supplement (diary no. 24-352) (this "**Supplement**") is a supplement to, and shall be read together with, Landshypotek Bank AB's (publ) (the "**Company**") base prospectus dated 15 June 2023 (diary no. 23-14179) (the "**Base Prospectus**"). This Supplement has been prepared for the purpose to (i) incorporate the terms and conditions of the Notes and Covered Bonds contained in the Company's base prospectus dated 19 May 2022, and (ii) make necessary amendments to the Form of Final Terms as result of (i).

At the time of publication of this Supplement, there are no outstanding offers to purchase or subscribe for MTN under the Base Prospectus and thus there is no right of revocation.

Amendments and supplements to the Base Prospectus
