This supplement (diary no. 22-15925) (this “**Supplement**”) is a supplement to, and shall be read together with, Landshypotek Bank AB’s (publ) (the “**Company**”) base prospectus dated 19 May 2022 (diary no. 22-10450) (the “**Base Prospectus**”). This Supplement has been prepared in accordance with Article 23 of Regulation (EU) 2017/1129 of the European Parliament and of the Council of the 14 July 2017, been approved and registered by the Swedish Financial Supervisory Authority on the 16 June 2022 and published on the Company’s website, <https://www.landshypotek.se/en/about-landshypotek/investor-relations/investment-programmes/funding-programmes/>, the same day. Excluding the incorporated documents, the information on the website does not form part of this supplement or the Base Prospectus and has not been reviewed or approved by the Swedish Financial Supervisory Authority.

This Supplement has been prepared for the purpose to (i) incorporate the Terms and Conditions of the Notes and Covered Bonds contained in the Company’s base prospectus dated 7 May 2021, and (ii) make necessary amendments to the Form of Final Terms as result of (i).

At the time of publication of this Supplement, there are no outstanding offers to purchase or subscribe for MTN under the Base Prospectus and thus there is no right of revocation.

Amendments and supplements to the Base Prospectus

- This Supplement incorporates the Terms and Conditions of the Notes and Covered Bonds of the Company’s base prospectus dated 7 May 2021, and thereby, the text on page 36 under “**DOCUMENTS INCORPORATED BY REFERENCE**” in the first paragraph item (iv) shall be replaced with the following wording:

- By this Supplement the text on page 39 under “**PART A – CONTRACTUAL TERMS**” in the third paragraph shall be changed to the following wording (amended text in the Base Prospectus is underlined):

“Terms used herein shall be deemed to be defined as such for the purposes of the Relevant Conditions set forth in the base prospectus dated [3 May 2019 / 4 May 2020 / 7 May 2021] which are incorporated by reference in the Base Prospectus dated 19 May 2022 (the Base Prospectus). This document constitutes the Final Terms of the [Notes/Covered Bonds] described herein for the purposes of Article 8 of the EU Prospectus Regulation and must be read in conjunction with the Base Prospectus [as supplemented by the supplement[s] to the Base Prospectus dated [] [and []]] which [together] constitute[s] a base prospectus for the purposes of the EU

Prospectus Regulation, including the Relevant Conditions incorporated by reference in the Base Prospectus, in order to obtain all relevant information. As used herein, EU Prospectus Regulation means Regulation (EU) 2017/1129 (as amended). The Base Prospectus [and the supplement[s]] [has] [have] been published on the website of the Issuer and copies may be obtained from the registered office of the Issuer. For each issue of [Notes/Covered Bonds], the Issuer will prepare the Final Terms for such issue and send a copy to the Issuing Agent.]”
